LISTED COMPANIES IN WHICH ENAGÁS, S.A. HAS A HOLDING

ENAGÁS, S.A. holds an indirect participation of 28.42% in the holding company that owns 100% of the politics rights and the 44,42% of the economic rights of Tallgrass Energy LP:

-On 11 March 2019 Enagás entered into an agreement with affiliates of Blackstone Infrastructure Partners and GIC (Singapore's sovereign wealth fund) to invest \$590 million for a 10.93% indirect ownership interest in Tallgrass Energy LP ("TGE"). Enagás investment is in the holding company that owns 100% of TGE's general partner, as well as approximately 44.42% of the economic interests in TGE (through the ownership of Class A and B Shares. Class A Shares are listed on the New York Stock Exchange).

-On 30 July 2019 Enagas increased 3,52% its indirect participation reaching a 28.42% stake in the share capital of the holding company.

OWN SHARES:

On June 30, 2020, the General Shareholders' Meeting authorized the Board of Directors to acquire own shares for a maximum term of 5 years.

On March 18, 2016, 29 March 2019 and 31 March 2022 the General Shareholders' Meeting approved a long-term incentive plan 2016-2018 ("ILP 2016-2018"), a long-term incentive plan 2019-2021 ("ILP 2019-2021") and a long-term incentive plan 2022-2024 ("ILP 2022-2024") respectively, that included the delivery of shares to the Executive Directors, members of the Management Committee and senior management of the Company and its group companies.

By virtue of the foregoing and according to the company's own shares policy approved by the Board of Directors of April 18, 2016, the said Board approved on April 18, 2016, April 23, 2019 and April 25 2022 respectively, both share repurchase programs, that allowed



the purchase of a maximum of 307,643 shares of the company under the first program, a maximum of 405,084 under the second one and a maximum of 679,907 under the third one. The repurchases were entrusted to a financial intermediary of recognized competence which has done so on behalf of the company, with independence and without his influence.

In execution of the foregoing, the company proceeded to repurchase the maximum permitted amount under the repurchase program approved on April 18, 2018, leaving a remnant of 96,862 shares after its delivery under the ILP 2016-2018, and in the same way the company proceeded to repurchase the maximum permitted amount under the repurchase program approved on April 23, 2019, leaving a remnant of 356,375 shares after its delivery under the ILP 2019-2021, and in the same way the company proceeded to repurchase 465.000 shares under the repurchase program approved on April 25, 2022, currently resulting in an amount of 821,375 own shares held by the company.
