

# Operation Note nº 6/2020 - 14.01.2021 – COLD SNAP (Continuation 2)

## EXCEPTIONAL OPERATING SITUATION – LEVEL ZERO – COLD SNAP

As a continuation of the Operation Note 06/2020, and considering the current forecasts of the State Meteorological Agency and the current situation, the **Cold Snap period started on January 1<sup>st</sup> 2021 is extended until January 17<sup>th</sup> 2021**, according to the criteria defined in the Action Plan winter for the operation of the gas system of November 27<sup>th</sup> 2017.

The predicted temperatures show an **extraordinary demand increase with respect to the predicted values under normal conditions around 3,700 GWh from the beginning of the Cold Snap on January 1<sup>st</sup> until January 17<sup>th</sup>.**

Therefore, the **EXCEPTION OPERATING SITUATION – LEVEL ZERO- COLD SNAP is extended from 06.00 a.m. on January 1st to 06.00 a.m. on January 18th, when it will be finished.**



